Operable Unit 1 (OU 1) Groundwater Remediation – HydroGeoLogic (HGL)

Separate minutes will be provided by HGL.

OU 1 Groundwater Remediation – Shaw

The Army sampled the offsite monitoring wells on 5/22/07 and a handout of the data was provided. The Army is evaluating the next phase of work for the offsite area.

Operable Unit 2 (OU2) and Sites 2/12 Treatment Systems

OU2 – The system operated with an average flow of 784 gallons per minute in June. Key events were described in a handout.

Sites 2/12 – The system operated at 218 gallons per minute in June. Key events were described in a handout.

Operable Unit Carbon Tetrachloride Plume (OUCTP) Record of Decision (ROD) and Pilot Study

ROD – Final language on this has been agreed upon by DTSC and EPA. The latest revision will be submitted to EPA 7/12/07.

Pilot Study – The Army received comments from DTSC on the pilot study work plan. The Army is preparing responses. Well installation is 70% complete. A tracer test is scheduled for August.

Other Groundwater Issues

Groundwater Sampling - The quarterly sampling was completed in June. MW-BW-25-180 and MW-BW 19-180R will be abandoned in July.

University Village – The OU2 excess water line has been rerouted and the old line will be removed next week. The infiltration gallery line will be rerouted next week. Discussed storm water discharge from planned apartments. The drainage area is small and not over a groundwater plume. No problems were anticipated from the project.

Groundwater Treatment System Optimization

OU2 – Extraction well EW-08 is operating and has been sampled.

OU2 Landfill Gas

Graphs of methane concentration from extraction wells, and the treatment system were distributed and discussed. The treatment system was shut down on 6/28/07 to test the landfill rebound and was restarted 7/9/07. Second quarter 2007 sampling was completed on 6/28/07. All compliance probes were below regulatory standards.

Basewide Range Assessment

A field work variance was issued for additional sampling at HA-119 (MRS-16).

Site 39 Ecological Risk Work

The Army received DTSC comments to the draft final report. The Army is preparing the final report which will address the comments.

Site 39 Feasibility Study (FS) Addendum

The draft report was submitted May 31, 2007. Comments were due 7/10/07. DTSC requested a 30 day extension to the comment period.

Site 3 Post Remediation Monitoring

A draft letter report was issued 4/30/07. Comments were due 7/6/07. The Army will issue the draft final report and begin preparation of a work plan.

FFA Schedules

The Site 39 schedule will be revised based on the extension to the comment period for the FS Addendum.

FOST/FOSL/FOSET

FOSET 5 – The document was submitted for a 30 day public comment period 6/28/07. There was a request for a 30 day extension to the comment period. The request was denied. There was also a request for a public meeting on FOSET 5. The Army will provide a presentation on the FOSET at the July CIW in response to this request.

FOST 10 – The Army received EPA concurrence on the document.

Five Year Review

The Army has addressed DTSC and EPA comments. The revised document will be submitted to EPA this week.

July CIW

The July CIW topics are the OU2 Landfill, FOSET 5 and the ESCA.
