Operable Unit 1 (OU 1) Groundwater Remediation – HydroGeoLogic (HGL) Separate minutes will be provided by HGL.

OU 1 Off-Site

Construction of the treatment system was delayed. This system is scheduled to start operations 7/11/08. Baseline samples will be collected 7/10/08. The additional monitoring well within the City of Marina has been delayed due to public concern about diesel fumes and concrete dust. Discussed a letter to address the public concerns. A handout of the status of the pilot study was provided.

Operable Unit 2 (OU2) and Sites 2/12 Treatment Systems

OU2 – The system operated with an average flow of 708 gallons per minute (gpm) for June. Operational issues were described in a handout.

Sites 2/12 –The system operated at 107 gpm for June. Operational issues were described in handout.

Sites 2/12 down time was due to communications issue at OU2. When OU2 shuts down, it also shuts down Sites 2/12 system. OU2 can be restarted remotely but Sites 2/12 requires a manual procedure to restart. This results in additional down time at Sites 2/12, especially if the shut down occurs outside normal working hours for the operator.

Other Groundwater Issues

Groundwater Sampling – The June sampling event was completed this week and included analysis for lead, copper and antimony at four A-aquifer wells downgradient from the landfill. The pump in Mini Storage well is not operating. It is not known if the owner intends to repair the pump. It was not possible to collect a sample in June. The Army will discuss the status of the pump with the property owner before the next BCT meeting.

Operable Unit Carbon Tetrachloride Plume (OUCTP) Pilot Study

A summary handout of the pilot study was provided. Monthly monitoring will be conducted through July 2008. The pilot study will be completed after the July sampling scheduled for 7/21/08. The Army will prepare a letter stating that the pilot study has been completed.

Groundwater Treatment System Optimization

Nothing new to report.

OU2 Landfill Gas

The Thermal Treatment Unit (TTU) system is operating three days per week. Methane levels are steady at 40%. A handout was provided.

Basewide Range Assessment

The Draft Final Post Remediation Risk Assessment for the Seaside Parcels was issued 7/1/08. Draft No Action Approval memos for Sites HA-79, HA-92, HA-98, HA-100, HA-121 and HA-183 were submitted for agency review 5/6/08.

A Draft Interim Action Approval Memo for site HA-161 was submitted 6/10/08.

Discussed the discovery of remnants of a livens projectile and associated TNT during excavation within an ESCA parcel along Gen. Jim Moore Blvd. The Army collected soil samples in accordance with a field work variance to the Basewide Range Assessment Work Plan.

Site 39 Feasibility Study (FS) Addendum, Proposed Plan, Record of Decision (ROD)

The Draft Responsiveness Summary will be submitted in late July.

Discussed the results of the conference call to resolve the Integrate Waste Management Board comments to the Proposed Plan and the proposed responses.

The site prep work planned for Ranges 19 and 26 was presented and a handout was provided.

Site 3 Post Remediation Monitoring

The Final Post Remediation Monitoring Plan was issued. The Army is working on a contract for State Parks to implement the plan.
