Operable Unit 1 (OU 1) Groundwater Remediation – HydroGeoLogic (HGL)

OU 1 Off-Site

Shaw issued a field work variance on 2/16/09 to shut down the groundwater treatment system and start the rebound study since all monitoring and extraction wells are below the ACL. FOEJN submitted comments on the field work variance. The groundwater treatment system was shut down and the rebound study was initiated on 2/17/09. Monthly sampling will be conducted until June 2009 and then sampling will be quarterly. A handout was provided.

Operable Unit 2 (OU2) and Sites 2/12 Treatment Systems

OU2 – The system operated with an average flow of 644 gallons per minute (gpm) in February 2009.

Sites 2/12 –The system operated with an average flow of 192 gpm in February 2009. A handout was provided.

EPA has no comments on the Sites 2/12 Construction Completion Report.

Other Groundwater Issues

Groundwater Sampling – The next sampling event started 3/9/09. The Mini-Storage well was not available for sampling.

The Draft Annual Report of Quarterly Monitoring October 2007 through September 2008 is scheduled to be submitted in late April. The report will include recommendations to reduce sampling frequency of monitoring wells which meet the established criteria for reduction. It will also include a comparison of total depth measurements from Sept 2008 to the original depth at the time the well was installed.

Operable Unit Carbon Tetrachloride Plume (OUCTP) Remedial Action

Well vault and pipeline installation was completed in Preston Park on 3/17/09. The Draft EISB Pilot Study Report will be submitted 3/19/09. A meeting with DTSC to discuss comments to the RD/RA Work Plan was held on 3/5/09. DTSC provided comments to the Army's original response to comments appendix on 3/9/09. A handout was provided.

GW Treatment System Optimization

The Draft Technical Memorandum, Groundwater Remediation Exit Strategy, Sites 2 and 12 and OU2 was issued 1/26/09. Comments are due by 3/31/09.

The Draft Annual Groundwater Treatment System Operation Data Summary Report, Jan-Dec 2008, OU2 and 2/12 was submitted 3/4/09. Comments are due by 5/4/09.

OU2 Landfill Gas

The Thermal Treatment Unit (TTU) system is operating three days per week. Methane levels are steady at 40%. Data is available on the Shaw Portal. A handout was provided. The current methane extraction approximately equals the methane generation.

Basewide Range Assessment

A Draft Interim Action Approval Memo for site HA-161 was submitted. Comments have been received and addressed. The memo will be issued to the public in April.

The Draft No Action Approval Memos for Sites HA-79, HA-92, HA-98, HA-100, HA-121 and HA-183 were submitted. Comments have been received and addressed. The memos will be issued to the public in April.

Site 39 Record of Decision (ROD) Amendment

The Army submitted the Final Site 39 ROD Amendment which is currently under regulatory agency review.
