Action Items List

Action Items list was updated from May OE BCT meeting.

- -Removal Action Updates submitted to agencies will also include meeting minutes.
- -USFWS concurred that no net loss would occur with East Garrison/Parker Flats proposed land use/habitat swap, therefore no formal consultation would be required.

Track 0 Record of Decision

- -DTSC is reviewing disclaimer language and is evaluating whether to sign the ROD or not.
- -EPA has minor wording changes and will provide to Army later today.
- -EPA is considering sending a letter to Army sometime next week to reiterate their position regarding OE being considered a hazardous substance, although this will not affect the Track 0 ROD.
- -EPA does not think DTSC needs disclaimer language for Interim Action Record of Decision because of the commitment to re-evaluate the Interim Action in the final Record of Decision.

Track 1 OE-62 (working draft)

- -DTSC suggested mentioning the background/qualifications of Mr. Stephani while he was stationed at Fort Ord.
- -DTSC requests a better explanation of training-related terminology and terms either in a glossary of terms or in an appendix.
- -A request was made to list the number of small arms and pyrotechnics found during reconnaissance.
- -Need to explain RAC score
- -Add an executive summary at the top of each site-specific section.
- -Harding to look into adding more level of detail in basewide range assessment.

Removal Action Update

- -East Garrison investigation concept in the works. To be discussed by SMART team.
- -Removal Action Update handout was provided.
- -R43-48 cleanup approach was discussed. A map detailing R43-48 was provided as a handout.
- -Del Rey Oaks prep work for machine gun area and berm has begun. DTSC to provide comments on draft final work plan.

Chartwell School plans

- -A tour of the Chartwell School site was given.
- -BCT discussed the nature of adjacent OE-49 boundary and agreed to begin consideration of boundary refinement.

IA RI/FS Schedule Review
