#### Fieldwork Update

Lyle Shurtleff provided an update on the status of fieldwork. A handout was provided.

## Fieldwork Variances (FWV)

- FWV SEA030: Gary Griffith to check on QC reference used for this FWV and discuss with Army.
- One new FWV was issued this month to the Programmatic Work Plan(PWP010)
- The Programmatic Work Plan (PWP) has a provision for the chapters to be revised once a certain number of Fieldwork Variances are issued, but there are administrative issues to consider since Parsons is at the end of their contract and the next contractor to come on board will write their own work plan. Both EPA and DTSC agree that it is okay not to go through with rewriting the entire Parsons' PWP but rather attach Fieldwork Variances to the PWP and site-specific work plan.
- Currently not all of the Fieldwork Variances issued on the PWP have been signed off by the agencies. Agencies currently review all Fieldwork Variances. The PWP currently

requires agency sign off on Fieldwork Variances. EPA and DTSC agree that agency review of Fieldwork Variances is sufficient. A Fieldwork Variance (FVF SEA030) to the PWP concerning using the 37mm as a QC cutoff item (grid failure criteria) was discussed. Gary Griffith will provide Roman Racca with a listing of Parsons' Fieldwork Variances for his reference.

# Track 1 Update

- A conference call was scheduled for April 21<sup>st</sup> to discuss the Record of Decision schedule and additional comments provided by DTSC on sites OE-1 and OE-13A.
- Rizgar Ghazi requested a set of maps for DTSC and would provide for the copying of these maps.

## **FFA Schedule Update**

The Track 2 FFA Scheduled was approved by the BCT. The Track 1 FFA Schedule will be updated to reflect the delayed draft final RI/FS report issue date of May 12 (previously agreed upon date). An alternative Record of Decision review schedule was discussed; EPA was okay with alternative schedule. DTSC to consider it and provide answer to the Army by April 21.
