## **Fieldwork Update**

- Discussed R43-48 special case areas. Very high anomaly density and also high density of sand gilia.
- Maximum fragmentation distance has been established for three zones. Distances are based on the following munitions: 1.) 75mm in northern sector, 2.) 105mm in mid-sector, and 3.) 155mm in southern sector.
- South Boundary: Army is looking at UXO walkabout since UXO is rarely found there. Fire agencies will feel more confident fighting fires from the road if they get a letter from the Army stating that a certain distance from the road has been cleared.

## Field work Variances

- PWP021 and PWP022 will be provided to the agencies.

## First Tee Project

- Lease is expected to be completed by May 1, 2004. Agency comments on the Finding of Suitability to Lease are needed as soon as possible. EPA provided preliminary comments relating to description of 100% sampling, education of construction workers on munitions recognition, and lease to specify golf course development only.

## Track 0 Plug-in

- East Garrison Area 1 Approval Memo is pending DTSC letter.
- Plug-in #2: Agencies have reviewed the list of parcels for consideration.
- Plug-in #3: These are parcels affected by Track 1. Army to provide maps for agencies to look at.

# Track 1 Update

- Discussed issues relating to the completion of the final report: MRS-49 sitewalk, DTSC trip report needed, construction education text, clarify Beach Ranges requirements
- Site write-ups and comment responses to the agencies this week for their review.
- Construction language with comments so far will be sent back to agencies this week.
- Habitat monitoring in Beach Ranges area was discussed. HMP monitoring requires monitoring activities within the areas the Army excavated.
