Property Transfer Update:

Regulatory agencies have concurred with FOST 8 and 9. An unresolved DTSC comment reference lead paint will be attached to the FOST 8 and 9. FOST 12 has been revised to address comments by EPA and DTSC. FOSET 5 is in revision to remove parcels that may be transferred in FOST 10.

Fieldwork Update: An update of current fieldwork was provided. A progress update on the MRS-Ranges 43-48 removal action was presented.

The scheduled completion date for Range 45 remains mid November 05.

Sifting work is complete (Range 45).

A vegetation (grasses) survey was reported completed in preparation for a cutting action planned on Fort Ord area north of South Boundary Rd.

DTSC deferred to EPA comments on draft final Seaside 1-4 TIP. DTSC will provide a letter to confirm.

Fieldwork Variances: **None**

Track 2 (Parker Flats) RI/FS: The DTSC military munitions contractor remains concerned about the accuracy of quality control actions for previous MEC removal actions. Army indicated confidence that the issue had been resolved between USACE and the DTSC contractor. DTSC will confirm the status of the contractor's issues.

Track 1 Plug In: Army indicated that two approval memos were in progress and would be sent to EPA and DTSC in the near future.

EPA requested from Army a list of the parcels scheduled to comprise FOST 10

The deadline for comments on draft RI/FS report has been extended to August 31. The deadline for issuing draft final RI/FS report was extended to October 31. The Army will update the Track 2 FFA schedule.

Track 1 Plug-in Program: The Approval Memorandum for East Garrison Areas 2 and 4NE; and another for all other groups in Track 1 are in process.

Track 3 Impact Area RI/FS: DTSC inquired about depleted uranium (DU) and the records of its use (if any) and its disposal. Army assured DTSC that there are no records that DU projectiles were used in weapons training on the former Fort Ord. Army will forward to documents that attest to that fact

MRS-16 Interim Action: Army presented information supporting a change in the strategy for protecting human health in the plan for MRS-16 vegetation burn. The Army cited the significantly reduced size of the scheduled burn (less than 60 acres), improved fuel breaks and the lack of metallic contaminants in air monitored during the 2003 prescribed burn as cause for a restructuring of the MRS-16 burn plan, removing relocation from the process. The Army will develop a process for modifying the existing IA OE RI/FS and a schedule for the development of a work plan.

DTSC relayed a CARB desire to be a full participant in the planning and execution of the MRS-16 burn.

FAA Schedule: Will be updated to reflect latest decisions in Track 2, Track 3, and MRS-16 (IA MR RI/FS).

Action Items: Army will review FODIS access for regulatory agencies.
