#### Former Fort Ord Property Transfer Document Status Update January 2006

FOST 8 (29 Parcels ~235 acres) and FOST 9 (29 Parcels ~1,888 acres)

• Six CRUPs for 18 parcels in FOST 8 and FOST 9 that are within the Prohibition Zone of the Fort Ord Special Groundwater Protection Zone. CRUP language finalized with DTSC, including a provision regarding payment of DTSC's costs for overseeing and administering the CRUP:

Costs of Administering this Covenant. The terms of this Covenant run with the land and will continue in perpetuity unless a Variance is granted or the Covenant is Terminated pursuant to section 6. The Department has incurred and will in the future incur costs associated with the administration of this Covenant. Pursuant to California Code of Regulations, title 22, section 67391.1(h), the Property Recipient (Owner) agrees to pay the Department's costs associated with the administration of this Covenant. In the event that Property ownership changes between the time the Department incurs administrative costs and the invoice for such costs is received, each owner of the property for the period covered by the invoice as well as the current owner is responsible for such costs.

Language forwarded to Fort Ord Reuse Authority (FORA) for review November 4, 2005. In a letter dated November 30, 2005, FORA agreed to this provision for groundwater restriction CRUPs, but not for MEC-related CRUPs until the terms of the ESCA are finalized.

Draft CRUP submitted to DTSC for final review December 12, 2005. DTSC attorney responded January 9, 2006, expressed concern DTSC's costs associated with administering CRUP would be borne by future owners of the property because Army is responsible for groundwater remediation and therefore should pay DTSC's costs through DSMOA. The Army can not do this. DTSC wants to be assured its oversight costs are covered. CRUPs are delaying transfer of property, needs to be resolved.

#### FOST 10 (29 Parcels ~800 acres)

- In progress. Schedule dependent upon completion supporting documents (i.e., approval memorandums and interim action confirmation report). Draft FOST estimated to be complete January 2006.
- Three CRUPs for Groundwater Prohibition Zone, one CRUP for residential restriction (already drafted). Seeking DTSC approval on area to be restricted.

#### FOSL 12 – Military Operations on Urbanized Terrain (MOUT) Site (portion of 1 Parcel ~46 acres)

- Comments received from USEPA November 29, 2005 and FOSL revised.
  - O USEPA comments regarding UXO as a hazardous substance. Text revised and Army will seek a waiver of 10 U.S.C. 2692 from Assistant Chief of Staff for Installation Management (ACSIM) for use of munitions on the property.

• Army determined FOSL should be staffed through DDESB because of munitions issues before obtaining signature of DASA(ESOH).

#### FOSET 5 – ESCA (49 Parcels ~3,478 acres)

- To keep FOSET on track, public comment period must start in February; therefore, agency comment period must start in January.
- Preliminary draft FOSET posted on the ESCA page of the FODIS web site in November for access by the regulatory agencies; however, the agency 30-day review and comment period is not considered to have started.

- Because of munitions issues, FOSET is in review by U.S. Army Technical Center for Explosives Safety (USATCES) and DDESB.
