#### **Property Transfer Status:**

FOSET 5 – Deeds are near final and need resolution of unrecorded easement issues. FOST 10 - Deeds need to be finalized.

#### ESCA:

A tabulation of recent and planned community outreach events was distributed. FORA described a new format for the status report. FORA reported continuing work in Parker Flats (PF) currently in Sec 4 cutting brush from the east end moving towards the west. DGM is pending the completion of current work. The local authorities report ready to assume responsibility for emergency services on the Parker Flats property. Efforts to address vandalism of survey markers were effective.

#### Fieldwork Update:

MEC Removal Fieldwork: A map of vegetation cutting progress and planning by area by type of equipment for Units 18/22 was described by Army.

Presidio of Monterey (POM) Fire Department provided a description of the prescribed burn conducted on Dec 10. The results of air monitoring during the burn were discussed. The draft of the After Action Report air monitoring will be published in March. Alternatives to the current burn prescription were discussed in conjunction with a pending draft of a burn plan for Units 14/19.

A work plan for Units 14/19 in 2009 was described by Army as pending with a draft planned in February.

## Site Security Program:

MEC Incidents: A modified response to a report of a "practice mine" by a hiker on BLM property in vicinity of Guidotti Rd. and Skyline Rd. on December 17 was described by the Army. Due to the description and reported disposition, BRAC staff investigated the location and determined the item to be a training aid. The item was then recovered and disposed as trash. An annual MRS Security Program Committee meeting was announced for 18 Feb at the Fort Ord BRAC Office.

### Track 3 Impact Area MRA:

The Army reported that EPA comments to the draft Remedial Design/Remedial Action Work Plan (RD/RA WP) have been received. DTSC intends to comment.

### **Track 2 Parker Flats MRA:**

Army requested regulatory agency comments to the RD/RA WP by the end of January. Army communicated that the POM is considering construction in the PF area in the Army-retained area as an option for student housing.

Remaining RI/FSs: The Army provided the draft work plan was planned for February.

DTSC comments to the draft Technical Information Paper E20c.1 Test Plot are pending. EPA will have no comments.
