
ALTERNATIVE SUBSURFACE REMOVAL TECHNIQUES FOR USE IN HIGH ANOMALY DENSITY AREAS WITHIN IMPACT AREA FUEL BREAKS AND BUFFER AREAS

Situation:

- removal are confirmed or suspected to have subsurface anomalies in a density and distribution that make removal using the DGM method of • Significant portions (approx. 20%) of fuel break and 100 ft buffer areas currently within the scope of the Track 3 ROD for subsurface digital mapping - reacquisition - excavation ineffective.
- A pilot study conducted in a sample area in Units 18/22 indicates that reacquisition can be hampered by a nearly continuous >14 mV DGM response within a anomaly saturated subsurface portion of a fuel break or buffer area.
- An analysis indicates that the situation is the result from a high density of metallic clutter (small pieces of MD and RRD) scattered over and within the first several inches of the soil (no MEC to date).
- The result is that selected anomalies cannot be effectively resolved using DGM reacquisition and confirmation. (insert Study data)
- Scraping in the study area increased the efficiency in the excavation of individual anomalies by reducing near surface metallic clutter (insert investigate initial anomalies and subsequent DGM picks and the investigation of all DGM anomalies even after a scrape may result in a soil • Scraping of a 4-6 inch surface of high density fuel break/buffer areas may significantly improve the capability of detection technology. Study data). However, the anomalies may remain in a density that requires an abnormally high number of team/hours to successfully disturbance equal to an effective excavation of the majority of the area.
- The use of analog vs DGM detection technology improves removal team/hour efficiency results in a satisfactory removal and can reduce the total soil disturbance in high anomaly areas.
- The use of scraping will require USF&WS consent, likely generate additional habitat management requirements and therefore should be minimized.

Recommendation:

•An alternative technique will be established and described in the No-Burn WP involving scraping of metallic clutter areas and an analog subsurface removal process to be used in high anomaly density areas where subsurface removal is required.
