Community Relations: Army provided an update on community relations actions.

- 1. The team reviewed the results of a meeting February 25 between the BCT and MIM as reported by Melissa Broadston.
- 2. The Army described the next CIW and TRC meeting as scheduled for April 11-12 and the annual nature walk in the impact area as scheduled for May 19.
- 3. FOR A described an upcoming Informal Community Workshop on March 29 hosted by the ESCA Remediation Program.

Property Transfer: The Army provided an update to current property transfer actions.

- 1. Finding of Suitability to Transfer (FOST) 11: No change
- 2. **FOST 12:** Received comments from BRAC-D, ELD and ODASA on March 1. Responses in progress.
- 3. **Finding of Suitability for Early Transfer (FOSET) 4 deed amendment:** DTSC reviewing and revising CRUP amendment.
- 4. Parcel L20.4 (Oil Well Rd) transfer to BLM:

Preliminary Draft Track 1 Plug-In Approval Memorandum for the BLM East/Post-1940 area is in Army internal review.

Environmental Law Division provided template for document for federal to federal property transfers.

ESCA Update: FORA provided an ESCA program update.

- 1. FORA continues to respond to multiple Keep Fort Ord Wild public records requests and their lawsuit.
- 2. Range 47 sifting continues with a planned DGM of the bottom of the excavation.
- 3. A MEC Investigation of Range 44 is complete.
- 4. FORA is developing a Habitat Restoration Plan for the Interim Action Ranges MRA.
- 5. FORA led a discussion of a response to a letter from the Fort Ord Community Advisory Grant (CAG) addressed to FORA, EPA, DTSC, and Army, requesting information previously provided in a separate correspondence. Army will draft a response to the CAG for review by all the addressees.
- 6. Remedial investigation fieldwork in Future East Garrison MRA continues with DGM target investigation on hold while waiting for permission from the US F&WS to cut an additional 50 acres.
- 7. Munitions response work is scheduled to move into the Parker Flats area in Apr-May. Some roadway closures will be required.

Fieldwork Update: The Army provided an update on recent and planned fieldwork.

- 1. Technology-assisted surface remediation in the interior of Units 11 is in progress with completion scheduled for April. DGM is in progress in Unit 12.
- 2. Subsurface remediation in fuel break roads (Phase B) under the work plan for non-burn areas is in progress.
- 3. Surface remediation in Unit 4 is in progress and is scheduled to be completed in April.
- 4. The total UXO items and MD lbs. processed in active units/areas to date was provided.
- 5. Detonation operations were conducted March 28 of items recently removed from Units 11/4 and fuel breaks grids. The results are pending.
- 6. Annual surface monitoring under Track 3 for surface remediated areas/units began in February and is scheduled to be completed in March. An annual report is scheduled for publication in May.

7. Army will provide BLM with a formal assessment of areas of Units 15, 21, 32, 34 subject to comment by BLM during review of draft of the SSWP.

Prescribed Burn Program:

- 1. Draft prescribed burn plan was issued in February (dated February 15) minus the internal security section which is pending. Review period ends March 26.
- 2. Fuel moisture reading in planned 2012 burn units will begin in April.
- 3. Cut of vegetation in the "Blueline" adjacent to the planned burn units is pending coordination.
- 4. The Army requested agency review of prescribed burn related outreach materials planned for publication in mid-June. Prescribed burn will be presented during the April CIW and TRC meeting in April.

Site Security Program: The Army provided the following information concerning the security of restricted MRS:

- 1. The annual MRS Security Program Committee meeting was held on February 28.
- 2. A site security program update will be presented to the April CIW and TRC meeting as a poster session.

Remaining RI/FS Areas:

- 1. The Army provided an update on the status of investigative work in the area of BLM-North. The fieldwork has been completed and a draft report has been published (2-22-12).
- 2. The Army provided a draft Track 1 approval memorandum addressing the areas of BLM-East/Post-1940 will be issued in April. The proposed Track 1 area will be called BLM Area A.
- 3. Draft Track 2 remedial investigation report for MRS-34 (FAAF) is scheduled for publication at the end of March.

Report Status: The Army provided a review and update:

- 1. Comments on the DF BLM-East Pre-1940 (N/S Portions) Site Assessment Data Report (#3) were received from MIM on February 28. A response is in progress.
- 2. Comments on the D BLM-North Pre-1940 (N/S Portions) Site Assessment Data Report (#4) are due on 26 March.
- 3. Comments on the D MRS-BLM Units 7 and 10 (2012 Units) Prescribed Burn Plan (includes air sampling and analysis plan) issued February 15 are due March 26.
- 4. Comments on the D MRS-BLM Units 6, 7, and 10 SSWP MEC Remedial Action are due March 26.

FFA Schedule: The Army provided a review of the FFA schedule.
