ESCA Update: FORA provided an ESCA program update:

A response to trespass and tagging of advisory signs in FORA property is pending.

Community Relations: Army provided an update on community relations actions: Tours for community organizations including a veterans group discussed. A mobile Community Involvement Workshop and a Technical Review Committee meeting scheduled for 8-9 August were described.

Registration for prescribed burn Direct Notification Program is ongoing.

Property Transfer: The Army provided an update to current property transfer actions:

- 1. FOST 11: BRACD and ELD coordinating with OGC.
- 2. FOST 12: comments received from DTSC 7 Aug. Revised FOST sent to ELD.
- 3. **FOSET 4 deed amendment**: DTSC to execute and record CRUP.
- 4. Parcel L20.4 (Oil Well Rd) transfer to BLM: No change.
- 5. RCRA corrective action completion determination: No change.

Fieldwork Update/Security: The Army provided an update on recent and planned fieldwork:

- 1. A map identifying the locations of significant (potentially influential on future cleanup activities) surface MEC finds during recent remediation activities was provided.
- 2. The Army is drafting a response to the BLM comments that was deferred pending completion of surface MEC removal and DGM of Units 15, 21, 32, 34. The response to comments will be included in the RAR for the Units.
- 3. Technology-aided surface removal and DGM in Units 11 and 12 is complete minus target, tree, and habitat grids. DGM has begun in Unit 4.
- 4. Work has been restarted in Phase B and C fuel break subsurface removal areas.
- 5. The totals for UXO items and MD (lbs.) processed in active remediation units/areas to date were provided.
- 6. Technology-aided surface removal in Units 2/3/4 is complete.

Prescribed Burn Program: The Army provided the following information:

- 1. The air monitoring station locations have been confirmed, and right of entry has been negotiated with property owners except for one school.
- 2. A prescribed burn information presentation was given to Seaside City Council on 2Aug.

Site Security Program: The Army provided the following information concerning the security of restricted MRS.

No site security incidents were reported.

Remaining RI/FS Areas: The Army provided an update on the status of work and documentation in the MR areas remaining to be completed:

An adjustment to the description of acreages of MRSs within BLM Area A will be made to the next version of the Track 1 document to reflect resolution of acreages associated with overlapping sites.

FAAF RI: Draft final Track 2 RI report was issued 31 July. Status of the current CRUP was discussed. The Army will contact City of Marina to offer a briefing on the project.

Report Status: The Army provided a review and update:

The final Technical Memorandum MRS-BLM Units 15and 21 is delayed to 31 August.

Draft Remedial Action Report for MRS-BLM Units 15, 21, 32, and 34 is scheduled to be issued 31 August. Draft final Track 1 Plug-in Approval Memorandum for BLM Area A is scheduled to be issued 31 August for a 30-day public review period.

FFA Schedule: The Army provided a review of the FFA schedule. Revision to the schedule for the Remaining RI/FS Areas program documents was approved by the MR BCT. The FFA will be revised to reflect that the agency review period for the draft final Track 2 RI for MRS-34 (FAAF) will be September 2012.

Action Items: The Army provided a description of action items due and pending. The next meetings of the MR BCT were scheduled for September 25 at 10:00 a.m. and October 10 at 1:30 p.m. at the BRAC Office.
