ESCA Update:

FORA representative was not available at the meeting.

Community Relations: Army provided an update on community relations actions:

- 1. The first mobile Community Involvement Workshop and a subsequent Technical Review Committee meeting were held on 8 and 9 August respectively.
- 2. Registration for prescribed burn Direct Notification Program is ongoing. A total of 573 have registered as of 17 September.
- 3. Army participated in the CSUMB Otter Showcase (new student orientation) on 29 August.
- 4. Bus tours were provided to NPS classes on 29 August and 2 September.

- 5. Army staffed a cleanup information booth at the Monterey County Fair 31 August (FORA on 1 September).
- 6. Army provided a description of a Nature Walk scheduled for October 27.
- 7. Army described a schedule for issuing the draft report of analysis of 2011 community relations survey.
- 8. The BCT discussed the impact of changing CIW format from meeting to bus tour and presentation.
- 9. BLM described the results of a September 24 public informational meeting reference the Fort Ord National Monument.

Property Transfer: The Army provided an update to current property transfer actions:

- 1. **FOST 11:** A conference call between BRACD, ELD, OGC and Fort Ord BRAC was held on 24 September. ELD and OGC are preparing responses to USEPA and DTSC comments.
- 2. **FOST 12:** comments on draft FOST received from USEPA dated 19 September. No other comments have been received.
- 3. **FOSET 4 deed amendment**: USACE SPK Office of Counsel sent revised deed amendment to BRAC Office 4 September. Revisions are in progress. DTSC resubmitted executed CRUP amendment to Monterey County 7 Sep. CRUP Amendment recorded 17 September.
- 4. Parcel L20.4 (Oil Well Rd) transfer to BLM: No change.
- 5. **RCRA corrective action completion determination**: No change.

Fieldwork Update: The Army provided an update on recent and planned fieldwork:

- 1. A map identifying the locations of significant (potentially influential on future cleanup activities) surface MEC finds during recent remediation activities was provided.
- 2. The Army has drafted a response to the BLM comments that was deferred pending completion of surface MEC removal and DGM of Units 15, 21, 32, 34. The response will be included in the RAR for the Units.
- 3. DGM in Unit 4 is 45% complete.
- 4. Work has been restarted in Phase B and C fuel break subsurface removal areas.
- 5. Technology-aided surface removal in support of planned prescribed burn is complete.
- 6. Preparation to begin MEC work in 100-ft buffer of MOUT Site is pending a determination of initial (ROD) alignment with agencies likely responsible for fire protection of MOUT and adjacent property and coordination of access restrictions during MEC work.
- 7. The totals for UXO items and MD (lbs.) processed in active remediation units/areas to date were provided.
- 8. The type of MPPEH items detonated on 9-13-12 was described. The itemized result of the detonation is pending.
- 9. There was no change to site security data for September.

Prescribed Burn Program: The Army provided the following information:

1. 26 September will be the last prescribed burn preparatory meeting.

- 2. BLM's work on R30A helipad is being finished today. Stabilizer to be applied on 3 October. The water tanks and helipad being ready by 5 or 9 Oct.
- 3. Presentations of the prescribed burn plan to Salinas, Marina, and Monterey City Councils were completed in September.
- 4. Meeting with Laguna Seca to discuss Black Out days was completed in August.
- 5. The Army is actively monitoring conditions to identify a potential burn window.

MMRP Safety and Site Security: The Army provided the following information concerning the security of restricted MRS.

- 1. A UXO safety presentation was provided to York School students and staff, 10 August.
- 2. A MEC incident in Unit 18 occurred on September 17. A report is pending.

Remaining RI/FS Areas: The Army provided an update on the status of work and documentation in the MR areas remaining to be completed:

The 30-day public review period for Track 1 Approval Memorandum for BLM Area A began on 27 August and will end on 27 September. No comments have been received.

FAAF RI:

- 1. The review period on draft final RI ended 5 September and no comments were received. The report will be finalized.
- 2. Draft Proposed Plan will be issued in October for agency review.
- 3. The City of Marina was contacted with the status of the RI and was offered a briefing on the project.

Report Status: The Army provided a review and update:

- 1. F Technical Memorandum MRS-BLM Units 15and 21 was issued 23 August.
- 2. D Remedial Action Report for MRS-BLM Units 15, 21, 32, and 34 was issued 31 August with comments due 9 October.
- 3. Track 1 Plug-in Approval Memorandum for BLM Area A was issued for a 30-day public review period 27 August to 27 September.
- 4. Impact Area MRA Surface Remediation Area Annual Monitoring Report (2012) was issued 12 September.
- 5. Final FOST 12, Parcels E20c.1, E29b.3.1 and S2.1.2 is planned for issue in October.
- 6. Draft Track 2 Fritzsche Army Airfield (FAAF) Proposed Plan is planned for issue in October.

FFA Schedule: The Army provided a review of the FFA schedule. No change was required.

Action Items: The Army provided a description of action items due and pending. The next meetings of the MR BCT were scheduled for October 10 at 1:30 p.m. at the BRAC Office; December 11 (later rescheduled to December 7) at 10:00 a.m. at the AMEC in Petaluma, CA; and January 23, 2013 at 10:00 a.m. at the BRAC Office.
