ESCA Update: FORA provided an ESCA program update:

- 1. Vegetation removal to support the ESCA Level 2A Residential Quality Assurance MEC remediation work in Parker Flats begins today.
- 2. Bulletins concerning munitions safety and trespass have been placed on the FORA website.
- 3. The community meeting pertaining to the vegetation removal to support the ESCA Level 2A Residential Quality Assurance MEC remediation work in Parker Flats that was held on 20 September was attended by 72 community members.
- 4. The number of community tours of FORA/ESCA activities has increased to 4 per year.
- 5. Requests for ESCA public records have increased.

- 6. FORA/ESCA is not writing new Rights of Entry while the current Right of Entry process is reviewed.
- 7. The City of Seaside has made a significant number of requests for documents for information regarding the Veteran's Cemetery which is an ESCA property.

Community Relations: Army provided an update on community relations actions:

- 1. EPA and DTSC noted that their offices had received congressional requests for information regarding environmental justice issues within their jurisdictions to support a congressional hearing on the subject.
- 2. Registration for prescribed burn Direct Notification Program is ongoing. A total of 580 have registered as of 9 October.
- 3. Army provided a description of a Nature Walk scheduled for October 27.
- 4. Army described a schedule for draft report of analysis of 2011 community relations survey and 2011-2012 outreach program.

Property Transfer: The Army provided an update to current property transfer actions:

- 1. **FOST 11:** No change.
- 2. **FOST 12:** comments on draft FOST received from USEPA dated 19 September. No other comments have been received. A response to USEPA comments is in progress.
- 3. **FOSET 4 deed amendment**: USACE SPK Office of Counsel sent revised deed amendment to BRAC Office 4 September. A revised deed amendment was returned to USACE SPK Office of Counsel on October 2.
- 4. **Parcel L20.4 (Oil Well Rd) transfer to BLM**: Response to ELD completed. No comments received on Track 1 Approval Memorandum for BLM Area A.
- 5. RCRA corrective action completion determination: No change.

Fieldwork Update: The Army provided an update on recent and planned fieldwork:

- 1. A map identifying the locations of significant (potentially influential on future cleanup activities) surface MEC finds during recent remediation activities was provided.
- 2. The Army has completed a response to the BLM comments that was deferred pending completion of surface MEC removal and DGM of Units 15, 21, 32, 34. The response will be included in the RAR for the Units.
- 3. Planned MEC removal and DGM in Units 11/12 has been completed minus grids containing APC targets, protected habitat, and qualifying trees.
- 4. DGM in Unit 4 is 55% complete.
- 5. Work continues in Phase B and C fuel break subsurface removal areas.
- 6. Preparation to begin MEC work in 100-ft buffer of MOUT Site is being coordinated with agencies likely responsible for fire protection of MOUT and adjacent property. Once coordination is complete vegetation removal to support MEC removal will begin and MEC removal upon receipt of approved ESS.
- 7. The totals for UXO items and MD (lbs.) processed in active remediation units/areas to date were provided.
- 8. The types of MPPEH items detonated on October 3 and 4 were described. The description of the result of the detonation is pending.

Prescribed Burn Program: The Army provided no change to the previous report. All site preparation is complete, and burn weather forecasting is ongoing.

MMRP Safety and Site Security: The Army provided the following information concerning the security of restricted MRS.

- 1. 4 MEC incidents were reported in August and September. All were resolved to be MD. Those reports bring the total year to date to 13.
- 2. There was no change in the number of community education recipients or personnel receiving MEC recognition and safety training.

Remaining RI/FS Areas: The Army provided an update on the status of work and documentation in the MR areas remaining to be completed:

The 30-day public review period for Track 1 Approval Memorandum for BLM Area A ended on 27 September. No comments were received.

FAAF RI: The Army provided a review and update:

Draft Proposed Plan will be issued in October for agency review.

Report Status: The Army provided a review and update:

- 1. Draft Remedial Action Report for MRS-BLM Units 15, 21, 32, and 34 was issued August 31. Comments were received from EPA and DTSC expressed interest in providing comment. A response to comments is in progress.
- 2. Track 1 Plug-in Approval Memorandum for BLM Area A was issued for a 30-day public review period 27 August to 27 September.
- 3. Impact Area MRA Surface Remediation Area Annual Monitoring Report (2012) was issued 12 September.
- 4. Final FOST 12, Parcels E20c.1, E29b.3.1 and S2.1.2 is planned for issue in October.
- 5. Draft Track 2 Fritzsche Army Airfield (FAAF) Proposed Plan is planned for issue in October.

FFA Schedule: The Army provided a review of the FFA schedule. The regulatory agencies approved a proposed revision to the Track 3 FFA schedule.

Action Items: The Army provided a description of action items due and pending.

The next meetings of the MR BCT were scheduled for December 7 at 10:00 a.m. at the AMEC in Petaluma, CA; and January 23, 2013 at 10:00 a.m. at the BRAC Office.
