ESCA Update: FORA provided an ESCA program update:

1. ESCA met with Monterey County Sherriff's deputy to coordinate and improve ESCA property patrol effectiveness. Based on feedback from public, ESCA and the deputies that have been on patrol.

Community Relations: Army provided an update on community relations actions:

1. EPA (J. Chesnutt) provided a summary of contacts with EPA concerning congressional testimony on environmental justice. EPA has received a letter contesting Fort Ord open space policies, the cutting of trees to facilitate cleanup,

restrictions on Parker Flats property use, and water rights issues relating to Fort Ord property.

- 2. Registration for prescribed burn Direct Notification Program is ongoing. The total of 580 has remained since October 9.
- 3. DTSC (R. Racca) described participation in a Phoenix stakeholder's meeting on new subsurface munitions detection technology. The response of stakeholders was positive.
- 4. The results of the analysis of the Army's recent community survey were described. Army requested DTSC comment on the conclusions.

Property Transfer: The Army provided an update to current property transfer actions:

- 1. **FOST 11:** OGC will schedule a meeting with DASA (EOSH).
- 2. **FOST 12:** USEPA provided concurrence on FOST on Nov 13. DTSC provided concurrence on Dec 6. The FOST has been staffed for the signature process.
- 3. **FOSET 4 deed amendment:** A conference call with BRAC, SPK OC, SPK RE was held to reach agreement on revisions to the deed. SPK OC still to review provisions for land use restrictions and long term management measures.
- 4. **Parcel L20.4 (Oil Well Rd) transfer to BLM**: USEPA concurred on Track 1 Plug-In Approval Memorandum for BLM Area A on Nov 1. DTSC completed its review on Oct 25. The ECP Update Report has been finalized. The property reassignment package is in progress.
- 5. **RCRA corrective action completion determination**: No change.

Fieldwork Update: The Army provided an update on recent and planned fieldwork:

- 1. A map identifying the locations of significant (potentially influential on future cleanup activities) surface MEC finds during recent remediation activities was provided.
- 2. A report of the results of a joint site inspection of Units 4/11/12 to address BLM comments deferred pending completion of surface MEC removal and DGM is complete and will be included in the TM for those units.
- 3. DGM in Unit 4 is complete except for footprint of a range structure pending demolition.
- 4. Work continues in phase C fuel break subsurface removal areas.
- 5. Start of MEC fieldwork in 100-ft buffer of MOUT Site is pending a selection of a contractor. Vegetation removal to support MEC removal will begin with contract award and MEC removal procedures modified via a FWV to accommodate topography. The location and configuration of the buffer has been coordinated with BLM, FORA and their fire agencies.
- 6. The totals for UXO items and MD (lbs.) processed in active remediation units/areas to date were provided.
- 7. The types of MPPEH items detonated on Nov 15 and Nov 29 were described. The description of the result of the detonations is pending.

Prescribed Burn Program: The Army provided no change to the previous report.

MMRP Safety and Site Security: The Army provided the following information concerning the security of restricted MRS.

- 1. 2 MEC incidents were reported in November. One was resolved to be MD. The other is pending investigation. Those reports bring the total incidents year to date to 15.
- 2. A school MEC safety presentation was provided to Highland Elementary School on Nov 16. The total recipients for 2012 is 375.
- 3. There was no change to the number of personnel training in MEC Recognition and Safety for 2012 (77).
- 4. DTSC (R. Racca) asked how community MEC safety will be provided after Army completes the cleanup. Alternatives were discussed without conclusion.
- 5. An analysis of the incident involving transport of a M19 white phosphorus rifle grenade to Operable Unit 2 Landfill during soil remediation operations was provided. DTSC requested a clarification of a statement within accompanying handout: "Production may have been perceived as superseding quality." The Army provided that the possibility of such a perception needed to be stated so as to ensure corrective actions included that possibility even though there is no evidence to that effect.

Remaining RI/FS Areas: The Army provided an update on the status of work and documentation in the MR areas remaining to be completed:

- 1. Newspaper advertisements announcing the completion of the Track 1 plug-in process for BLM Area A have been issued Dec 3 and 4.
- 2. The Army is in the process of preparing a Track 2 RI/FS for BLM Area B. The area includes several MRSs where previous actions included site walk to subsurface MEC removal. The data is being compiled and evaluated. A scoping meeting with the regulatory agencies is anticipated. A Track 1 approval memorandum will be prepared for BLM Area C.

FAAF RI: The Army provided a review and update:

1. Draft Proposed Plan for MRS-34 was provided for agency review in October. DTSC will provide a letter concerning its policy on unrestricted use on Track 2 sites.

Report Status: The Army provided a review and update:

1. Draft final Remedial Action Report for Units 15, 21,32, and 34 is schedule for issue in January.

FFA Schedule: The Army provided a review of the FFA schedule. No change was required.

Action Items: The Army provided a description of action items due and pending.

The next meeting of the MR BCT scheduled for January 23 at 10:00 a.m. will be rescheduled.
