

- 1. January 2014 FORA notified FO-BRAC of errors in deed amendments for ESCA property in Parker Flats and County North. FORA stated the ultimate grantees (County of Monterey, Monterey Peninsula College and the State of California) will not accept the property until these errors are corrected.
