Enclosed for your information is the revised schedule for submitting primary documents under the Fort Ord Federal Facility Agreement pertaining to timetables and schedules for the Military Munitions Response Program at the former Fort Ord.

The schedule for the Track 2 Bureau of Land Management (BLM) Area B and Munitions Response Site 16 (MRS-16) Remedial Design/Remedial Action program was revised to reflect the actual agency review period for the draft Land Use Control Implementation Plan. This revision also identifies a schedule for submitting a report on the recently completed prescribed burns within Units B and C. The revised schedule was reviewed and approved on November 8, 2017, by U.S. Environmental Protection Agency (EPA) during the Munitions Response Base Realignment and Closure Cleanup Team monthly meeting, and by California Department of Toxic Substances Control (DTSC) in a follow-on communication.
